内容概要

统一商法典是美国法律演进历史中最引人注目的成就之一。

统一商法典的内容基于商业交易的不同环节。

法典分为11篇，以总则和各分则的形式，在实践中的商事规则和惯例进行了归纳和体系梳理，涉及货物销售合同、消费租赁、融资租赁、商业票据法、银行存款单据、资金转移、信用证、仓单、提单、投资证券和担保等方面的法律。

在结构方面，统一商法典由两部分组成：法律条文和附注于条文的官方释解；后者意在阐述法条的背景和原理，其重要性不亚于条文本身。

本书围绕着统一商法典，本书注重介绍了第二篇货物买卖合同、第三篇票据、第七篇仓单和存单、第九篇担保和第五款信用证等主要内容。

对于每一部分的内容，作者都根据相应地条款加以解释说明。

为了读者阅读方便，本书还附有一百多项统一商法典的条文索引。
