章节摘录

版权页：The original third paragraph serves as the fourth paragraph and is amended to read as follows: "Where an entity commits any of the crimes mentioned in the preceding second and third paragraphs, a fine shall be imposed on the entity, and the persons directly in charge of the entity and the other persons directly responsible for the crime shall be punished respectively in accordance with the provisions of the corresponding preceding paragraphs.

"13. One article is added after Article 388 of the Criminal Law as Article 388a, which reads as follows: "Any of the close relatives of a State functionary or any other person closely related to a State functionary, who, through that State functionary's performance of duties or through another State functionary's performance of duties by taking advantage of that State functionary's power of office or position, secures illegitimate benefits for an entrusting person, or extorts from the entrusting person or accepts the entrusting person's money or property shall, if the amount involved is relatively large or if there are other relatively serious circumstances, be sentenced to a fixed term of imprisonment of not more than three years or criminal detention and be concurrently imposed with a fine; if the amount involved is large, or if there are other serious circumstances, such persons shall be sentenced to a fixed term of imprisonment of more than three years but not more than seven years and be concurrently imposed with a fine; if the amount involved is especially large, or if there are other especially serious circumstances, such person shall be sentenced to a fixed term of imprisonment of not less than seven years and be concurrently imposed with a fine or confiscation of property.
