为了进一步提高学习者对法律案例的分析能力,在原有的案例基础上增加了案情简介、案例问题和案例摘要实践等内容并配有参考答案。

案情简介用以引导学习者对案件事实及法院通过案件所制定的法律有更加明确的了解。

案例问题是针对案件提出问题,培养学生在阅读案例的同时,观察法律语言所承载的法律知识。

案例摘要实践旨在使学习者通过案例摘要的写作,领会法官的法律推理过程,提高思辨能力。

同时,在修订过程中也对原书中的术语翻译、注释释义、篇章内容等方面进行修改与完善。

Law consists of the whole body of rules applied and enforced under the authority of established government in determining what conduct iS pro~er and should be permitted and that which should be denied or pertalized. Without law, there would be anarchy. Law is the means through which society isable to exist by providing protection for the individual; by establishing and maintaining order, health, and safety; by providing a peaceful mean \$ of dispute resolution: by providing stability and flexibility in economic relations between people ; and byprohibiting conduct destructive to society. Rules reflect the society and time in whichthey operate. Growth of law has been pragmatic, developing from society's need forreasonableness and flexibility in its day-to-day working.
